Who are Grey Wolf Publications?

Grey Wolf Publications are a new ebook publishing house looking to publish quality paranormal, spiritual and new age ebooks. It is important that people can come back time and again to look for ebooks which can help them on their spiritual path.

It is owned by Alec and Debbie Summers who are Tarot, rune and palm readers and Reiki Masters. We also are very interested in the paranormal and take orb and ghost photos. We are co-authors of the book, “Orb and Ghost Photos”. You can find out more about us [here](#).

Privacy and Security

We will never sell, give away or pass any of your information to any third party. We abhor junk mail and spam and we will not betray your trust by letting anyone anywhere near your details. We will protect you at all times. We respect your privacy and we will not spam you with information that you don't want. What types of formats do you offer?

We sell our ebooks in a variety of formats including Word, pdf, Rich Text Format, Mobipocket (prc) and Kindle. Some books are only available in one or two formats due to its content. We hope to add other formats at a later date. Most formats are not encrypted.

Do you arrange cover art?

We can arrange cover art for your ebook if you wish. If you can create your own cover art, please do so and we will include it in your ebook if we deem it suitable.

Do you charge any fees for publishing my ebook?

Definitely not. We only take 50% of any profits we receive on the sale of your ebook (see next question for further details).

What royalties should I expect?

As expenses for publishing ebooks are so much lower than printed books we are able to offer our authors 50% royalties of any profit we make. This means that we will give you 50% of the purchase price of your ebook if it is sold directly on www.greywolfpublications.com. If the ebook is sold on www.lulu.com, you will receive 50% of the money which we receive. Full details of exact royalties will be given to you before publication.

We are a very small publishing website so you are unlikely to sell thousands of copies of your ebook. There is a lot of competition out there both on the internet and in bookshops. Ebooks only account for a very small percentage of sales of books at present but it is a growing market. It was recently reported in the news that sales of ebooks will out perform

the printed form by 2018. We will do our best to help you to sell as many ebooks as possible but we need your help with marketing to get the best results.

When will I be paid the royalties I am owed?

Provided you have a minimum of £10 (British pounds sterling) owing to you, we will pay you on the 1st Monday of every month by Paypal, therefore you must have a Paypal account.

Do I keep the copyright to my book?

Yes, you keep all rights to your book. This means that you can publish your work with other publishers providing they do not want sole rights or that we don't already publish your ebook with them.

Do I have to give you notice if I wish to leave Grey Wolf Publications?

All we ask is that you give us 60 days notice if you decide to leave us. This is to enable us to remove your ebook(s) from all the websites we use and arrange final payment of any royalties that may be due to you.

Obviously, any ebooks that have been sold (or free sample chapters/ebooks that have been downloaded) cannot be returned to you.

Do I have to get involved in marketing my book?

We expect our authors to spend time in marketing and promoting their ebooks to enable them to sell as many as possible. We will promote your ebooks too by ensuring that they are included on www.greywolfpublications.com and www.lulu.com.

How do I go about sending you my book?

Please abide by the following guidelines before submitting your book. We will reject any manuscript that doesn't respect them. All books must be your original work. You must not send us any work that has been written by anyone else. This is illegal and we won't be held responsible for the consequences.

We are not interested in work that encourages criminal behaviour.

We will edit the work once accepted but please don't send us work that you haven't thoroughly checked yourself. If you don't spend the time and effort checking and rechecking your manuscript it is unlikely to be suitable for us to read.

Please create the following as one document in Word or RFT format and attach it to your email.

Covering Letter

Please write a covering letter that reflects the amount of time and effort that you have put into writing your ebook.

Please include:

1. your name, address and email address.
2. a paragraph about yourself and any experience or qualifications you have in your subject matter. Please note that qualifications aren't necessary, if the book is good we will publish it regardless.
3. title of book
4. word count

Synopsis

Please include a summary of your book which should be no more than two A4 pages long. It doesn't need to be broken down into chapters but we need to see that the book has a beginning, middle and end and has been well thought out.

Sample Chapters

We need to see the first three chapters.
